FMCA Northwest Area Executive Board met on December 15th. The topic was the 2021 area rally in Longview, Washington. Several factors were considered: difficulty in dealing with the caterer, limited power available, unavailability of portions of the facility, uncertainty of travel restrictions, and continuing COVID restrictions. Financial commitments would soon be required and registrations would need to open in the coming weeks.

Therefore, the FMCA NW Area board decided to cancel the 2021 FMCA NW Area Rally in Longview that was scheduled for June 24 – 27.

However – the NWTFC executive board has decided to move forward with the Rally on the Cowlitz for June 18 – 22 in Kelso.

the 747/777/787 plant in Everett, Paul Allen's Flying Heritage Museum, and the Museum of Flight at Boeing Field.



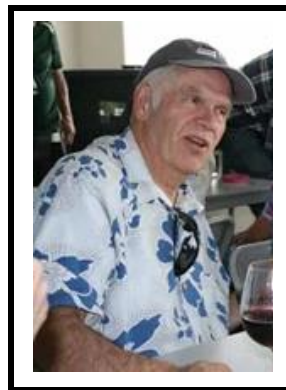

FMCAssist is one of the key benefits of FMCA membership. It is included in your annual FMCA dues at a very low price. Most of the membership benefits consist of discounts on purchases of tires, roadside assistance, insurance, and campground discounts. However, FMCAssist is a benefit that does not require members to purchase anything additional. It is a benefit that is available to everyone. And no other organization or company offers such a benefit for all members at no additional cost.

FMCAssist is an **emergency medical evacuation** and repatriation coverage available to FMCA members worldwide as long as you are more than **75 miles from home**. If you are a full-time RVer, you are always considered 75 miles from home. FMCAssist services are also available to members when traveling abroad.

Because of a high premium cost, FMCA sought a different provider for the program. As a result the dues were able to stay the same for 2021, the budget was balanced, and we have a better program.

FMCAssist medical evacuation program is now provided by CHUBB and is known as the Chubb Travel Assistance Program. Here are some additional benefits from previous program

- 75 miles from home base vs the former 100 mile distance from home requirement
- Accidental death & dismemberment is raised to \$5,000
- Emergency cash if trip interrupted. You spend the money and get reimbursed. Up to \$250 per day, 3-day limit, \$1500 maximum in 12 months.
- Emergency room cash. \$250 per person per visit, \$500 maximum in 12 months



Other key features:

- Applies when traveling with your motorhome or without it (by car, plane, ship, etc.)
- **Applies to US and Canadian members**
- Emergency medical evacuation - up to \$500,000
- Emergency medical reunion - up to \$50,000, family member travel expenses
- Return of dependents - up to \$50,000
- **RV return to permanent residence - no age limit of coach as long it is in good driving condition, up to \$5,000**
- Automobile return (non-RV trip) - up to \$5,000
- Pet return - only dogs and cats
- Prescription medication delivery - up to \$500
- Eyeglass replacement delivery (in emergency situation) - up to \$500

You must call the CHUBB contact number before you make arrangements. Note, if you ever need to use the FMCAssist program, use your FMCA F# as your identification number.

2020 was a year like no other with the difficulties posed by the COVID-19 virus. The spring and fall planning meetings for the FMCA NW area were cancelled, though some meetings were held by Zoom. The NW Area Rally scheduled for Roseburg was cancelled. The 2021 NW Area Rally in Longview, Washington has also been cancelled, primarily because of difficulties related to the facility and virus considerations.

The FMCA winter convention was scheduled for Tucson, Arizona and the summer convention was scheduled for Lincoln, Nebraska – however both were cancelled. With some added precautions and the beginning of the vaccine rollout, people are once again thinking of getting together. Plans are underway for the spring convention in Perry, Georgia in March and the summer convention in Gillette, Wyoming in July. This will be an important meeting since it is an election year and several important issues are being considered.

Even though the Governing Board did not meet, there were several important issues discussed during the year.

- Annual budget and FMCAssist. The FMCAssist medical evacuation program was adopted as a member benefit in 2014. Originally the premiums were funded from invested funds. At the 2018 convention it was reported that FMCA had lost some \$3 million and FMCAssist was really an operational expense. A poll of Governing Board members indicated that about 80 – 90% of members wanted to keep FMCAssist. So now the premiums come from current dollars, and the dues were raised to reflect this. The dues increase of \$25 was to ensure the cost of premiums was covered, even with a percentage of members having memberships that continue over a number of years.

Because of a projected premium increase, there was a proposal to eliminate the program and reduce the dues to \$50 per year.

However, a proposal from Chubb Insurance Company with a lower premium proposal enabled FMCA to keep the FMCAssist program and maintain a balanced budget at the same annual dues of \$75 per year.

- COVID liability concerns. Because of concerns related to the coronavirus, a liability form was proposed. There were issues associated with the suggested liability form. The form was discussed in a Zoom meeting by the NW Area and Zimmerman addressed several items directly. As a result the COVID liability form was revised and will be used for 2021 meetings.
- A marketing consultant submitted a proposal that sought to present some ideas for growing the membership. Zimmerman was involved in analyzing the presentation. The difficulty is that FMCA has historically been oriented to motorhome owners of means who like to travel far from home. Purchasers of most new RVs may reflect a different market with different interests and needs. In the future FMCA will need to address these changes in the marketplace.
- FMCA is a unique RV owner's organization in that it is an association with a Governing Board composed of representatives of nearly 400 chapters from 10 areas. Policies are approved and officers are elected by this representative body. An executive board composed of 10 area vice presidents and 4 officers functions during the year. Questions have been raised about this organizational structure, however each member is assured that the Governing Board reflects the

membership's interests and perspective. On the other hand, a majority of members are not associated with a chapter.

- The 2021 elections to be held during the Governing Board meeting will elect a new slate of officers and may have a significant impact on the future direction of FMCA.
